- 1- **D'eden lover** _____ shall be bred only to males/females that
belong to _____ and that live permanently in his/her own house – cattery
_____ ; he/she will never be bred with other people's females/males.
- 2- I understand that he/she should never be caged.
- 3- D'Eden Lover _____ cannot ever be resold, given away, leased, lent or
exchanged, unless he has been previously neutered/spayed. If for any reason
Mr/Miss _____ can not longer keep him/her at his/her own home or use
him/her for breeding, he/she should be neutered/spayed first and then placed in a suitable loving
home.
- 4- The cat will leave France with a vet health's certificate. The new kitten's owner has 72 hours to
control the cat at his/her arrival together with the vet and if something is wrong must informed
Frederic Gaspard together with a vet's certificate that show all kitten's information (dob-name-
color-microchip numb.) and that clearly give the details of what was found. I agree with not using
CFA-Board – Protest committee for any issue or dispute can arrive with the breeder of the cat.
- 5- After communicate the kitten's problem the new owner, at his/her own expense, has 3 weeks to
ship the kitten back to **Gaspard Frederic**. The new owner will choose and will get a new kitten
available at that time or will wait for new litters to choose one in replacement. The kitten's

replacement will take place not later than one year of the fact. **Frederic Gaspard** will pay for the shipping of the new kitten to the destination. ***The price will be never refund but there will be always a kitten replacement.*** Up to Frederic Gaspard decide if a refund will take place.

6- We do not take responsibility for the cat's successes or failures, but also for when the cat will reproduce and at what age it all depends on the conditions in which the cat lives, this is the responsibility of the new owner.

7- Only deposit hold a kitten. All deposit are not refundable on a kittens due to change of mind. We reserves the right to refuse or cancel any sale without any justification. In the case where a deposit has been paid, it would be refunded (only what we got, we not refund bank charge, transfer charge, exchange rate,)

8- We accept payment facilities, but you need to respect date specified or we can cancel.

9- We not hold a kitten over 5 months old (except if we have agreement together). If it's not possible for you to adopt the kitten at time specified, hold fee of 20\$ per day, per cat will be charge.

10- This agreement does not contemplate any exceptions, and thus cannot be changed in any way. It is a permanent agreement, so no exceptions should ever be demanded or granted. I promise to abide by both the letter and the spirit of its clauses.
